**SCCS considers that Indigofera tinctoria is safe when used in non-oxidative condition hair colouring products at on-head concentrations of up to 25%.**

#### 4. FIRST AID MEASURES

- Ingestion:** No immediate danger. Do not induce vomiting, give a glass of water. If unwell seek medical attention and show this information.
- Inhalation:** Remove casualty to fresh air, keep respiratory passages clear and seek medical attention.
