<b>9</b>	Liquid and bar soap, depilatory, rinse-off conditioners, shampoos of all types including baby, facial cleansers , shaving creams , body washes, shower gels of all types, feminine hygiene pads and liners, other aerosols including air fresheners.
<b>10</b>	Hand and machine wash laundry detergents of all types including bleaches, other household cleaning products, dry cleaning kits, fabric softeners, hard surface cleaners of all types, pet shampoos, diapers, toilet seat wipes.
