ANNEX 1

Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by IFRA.

IFRA Category 1	Leave on products generally applied to lips: Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.); Children's toys	
FRA Category 2	Leave on products generally applied to axillae: Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne, etc.); Body sprays (including body mist)	
FRA Category 3	Products generally applied to the face using fingertips: Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer; Facial make up and foundation; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands, body; Body and face paint (for children and adults); Facial masks for face and around the eyes	
FRA Category 4	Fragrancing products generally applied to neck, face and wrists: Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, etc.), aftershaves of all types (except creams and balms); Fragranced bracelets; Ingredients of perfume kits an fragrance mixtures for cosmetic kits; Scent pads, foil packs; Scent strips for hydroalcoholic products	
FRA Category 5A	Leave on products applied to the body using the hands (palms): Body creams, oils, lotions of all types; Foot care products (creams and powders); Insect repellent (intended to be applied to the skin); All powders and talc (excluding baby powders and talc)	
FRA Category 5B	Leave on products applied to the face using the hands (palms): Facial toner; Facial moisturizers and creams (including care products for beard and moustache)

FRA Category 7B	Leave-on products applied to hair with hand contact: Hair sprays of all types (pumps, aerosol sprays, etc.); Hair styling aids non sprays (mousse, gels, leave-on conditioners); Hair permanent or other hair chemical treatments (leave-on) (e.g., relaxers), including leave-on hair dyes; Shampoo - Dry (waterless shampoo); Hair deodorizer, hair perfume

FRA Category 11A	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate, without UV exposure: Feminine hygiene conventional pads, liners, interlabial pads; Baby diapers; Incontinence pant, pad; Toilet paper (dry)	
FRA Category 11B	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate, with potential UV exposure: Tights with moisturizers; Scented socks, gloves; Facial tissues (dry tissues); Napkins; Pillow spray; Paper towels; Wheat bags; Facial masks (paper/protective) e.g. surgical masks no used as medical device; Fertilizers, solid (pellet or powder)	
IFRA Category 12	Products not intended for direct skin contact, minimal or insignificant transfer to skin: Candles of all types (including encased); Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragrancing of all types (concentrated aerosol with metered doses
